## Terms and Conditions:

As you are a licensed Energy Star fabricator, and NFRC approved, we will implement the Energy Star Version 7 Installation Compliance on-line program in a simple and effective manner keeping your company's identity, but under the AWDI "best practices" umbrella:

1. In concert with your IT people, we will make a custom landing page accessible from a link you put on your own website. This will allow AWDI to be responsible for the Installation Best Practices content, but carry your name in compliance with the Energy Star requirements\*\*. This page will contain your identity and logo (or any identity you wish).

2. The installation blocks will be linked to our server, however the instructions will be displayed in your website - no one will have to leave your site, but the instruction pdf files will come from ours. AWDI will pay all hosting fees for your Instruction Portal.

3. For copyright control, the instructions will require terms of acceptance from users prior download or printing. This moves the responsibility from your company to between the visitor and AWDI and protects our copyrights. If you want identity of those who access your portal, you can provide that intermediate step to be completed before they get to the "WIXSYS" page.

4. License/Subscription per Energy Star Certified Company will be charged at the special net rate of \$950\* per year (upfront payment). The contract is simple: AWDI will supply Energy Star and NFRC FenStar compliant library of installation instructions, with a personalized web page, accessible from your website and supplied from our server. We will provide the service for one year from date signed at which time the subscription/license would be renewable on annual basis. Initial contract to December 31, 2023.


5. There is a one-time setup/programming fee of \$150.00 with contract signing\*.

6. As an Option, we can exchange, modify or expand any of the supplemental sections, or add specific sections for your company. Each change is \$100. Any content creation will be quoted separately.

7. We will provide a FREE QR Code, carrying your install URL (FREE custom web address for your company), for you to place on your windows/literature to show the link to the library portal, so smart phones, etc. will go directly to your portal page.

8. Once we receive your application we will secure your custom URL and prepare your portal page and QR Code. This signed form will serve as a Letter of Agreement with these terms that your signature and payment confirm you have accepted. It will form the basis of our agreement. These guidelines serve as resource and reference only. Codes and local circumstances will supercede.

9. The AWDI/WIXSYS website and initiative will meet or exceed the EPA/Energy Star and NFRC requirements, and for any discrepancies we will make the needed corrections, adjustments, and/or additions to make them compliant. Periodic changes will be made as required by EPA, DOE, Energy Star or NFRC.
